I. Policy Statement

The University of Louisiana Monroe's (ULM) Reporting Misappropriations of University Assets Policy defines the procedure an employee is to follow in reporting any misappropriation of University funds or other assets whether the misappropriation or theft occurs on or off campus.

II. Purpose of Policy

The Reporting Misappropriations of University Assets Policy provides the procedure an employee is to follow in reporting any misappropriation of University funds or other assets whether the misappropriation or theft occurs on or off campus.

This policy facilitates the University's compliance with Louisiana Revised Statute 24:523 (Act 1101 of the 2001 Legislative Session).

III. Applicability

This policy is applicable to all University employees.

V. Policy Procedure

When a University Employee becomes aware of a misappropriation of public funds or other asset of the University – regardless of value, tagged or untagged, the employee shall immediately contact the University Police Department (UPD) for reporting and investigation.

When the University Police Department becomes aware of a misappropriation of public funds or other asset of the University – regardless of value, tagged or untagged, the investigation officer shall complete an incident report and immediately send a copy of the incident report to the University President, with a copy to the University Property Control Manager.

When the University President has actual knowledge of any such misappropriation, the University President will immediately notify, in writing, the Legislative Auditor of the State of Louisiana and the District Attorney of Ouachita Parish.

Monthly, the Property Control Manager will compare UPD incident reports relating to any misappropriation of assets to the President's letters to the Legislative Auditor and the District Attorney to ensure timely and complete reporting of misappropriated assets.

The University President is responsible for enforce	ment of this policy.
